### ORDER

WHEREAS, WRC,NCTE, had granted recognition/permission to Mehmuda Shikshan & Mahila Gramin Vikas Bahuddeshiya Sanstha's Central India College of Education, Survey No. 78, Behind Godhani Railway Station, Godhani(Rly), Nagpur-441123, Maharashtra vide order No. WRC/6-47/2003/4514 dated 09.07.2004 to start the B.Ed. Course with an annual intake of 100 students.

AND WHEREAS, the letter for submission of AFFADAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 12.01.2015. The Institution submitted affidavit vide letter dated 12.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

AND WHEREAS, the matter was placed in 387<sup>th</sup> Meeting of WRC on 9<sup>th</sup> & 10<sup>th</sup> June, 2023, the Committee decided that to issue show cause Notice to the institution of the condition maintained in the revised order and Order for Reduction of Unit/Intake vide letter dated 07.07.2023.

**AND WHEREAS,** The Institution has submitted reply against the show cause notice with documents required as per two basic Unit (each 50 students) and also request to restore the intake from 50 to 100 students.

AND WHEREAS, On scrutiny of the application submitted by the institution, the documents attached therewith, the committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, infrastructure, laboratory and that it fulfills such other conditions required for proper functioning of the institution for B.Ed. Course as determined by regulations.

AND WHEREAS, WRC considered the application to restore the intake from 50 to 100 from the academic Session 2023-24 with all the requirement as per NCTE Regulations and WRC decided to permit to restore in intake from 50 to 100 for B.Ed. Course to Mehmuda Shikshan & Mahila Gramin Vikas Bahuddeshiya Sanstha's Central India College of Education, the recognition of institute be continue.

NOW THEREFORE, in exercise of the powers vested under Section 14(3) of NCTE Act, 2014, the committee decided the recognition of the Mehmuda Shikshan & Mahila Gramin Vikas Bahuddeshiya Sanstha's Central India College of Education, Survey No-78, Behind Godhani Railway Station, Godhani(Rly), Nagpur-441123, Maharashtra for conducting B.Ed. Course of two year duration with an annual intake of 100 Students two basic unit of 50 students each is hereby restored and Institution is permitted to participate in the counseling being conducted for admission to B.Ed. course by the affiliating body/concerned state Govt., from the academic session 2023-24.
